Volunteer Code of Conduct

As a volunteer, I agree to abide by the following Volunteer Code of Conduct:

1. I will model a lifestyle that is consistent with what the Bible teaches and what parents would reasonably expect of a Christian ministry leader working with children.

3. I agree never to be alone with individual minors, or with a group of minors.
4. I will report any potentially inappropriate behavior I observe to church leadership.
5. I agree not to transport minors without the written permission of parents or guardians or without the written permission of the church, and I will never transport a minor alone.
6. I will not disclose, post, or disseminate video, photographs or any other personal information about minors without the written permission of parents or guardians.
7. I will not engage in any outside communication with students online, via text or phone.
8. I agree not to post, transmit, publish, or display harmful or inappropriate matter that is threatening, obscene, disruptive, derogatory, sexually explicit, or that could be construed as any form of harassment.
